Section A: Legal Volunteering in Nottingham

Pro Bono Society

The Pro Bono Society is made up of nine charitable projects.

Educational Projects

Aspire: Aspire conducts interactive workshops to introduce the concepts of human rights, justice, stereotyping and voting and elections to children in primary schools all over Nottingham.

OutLAW: OutLAW volunteers deliver a variety of workshops that help students in applying to university, gaining employability skills and give them an insight into the legal career.

Penal Reform

Unbarred: This project involves going into a variety of different prisons to conduct workshops for inmates who are soon to be released.

The Howard League: The Howard League for Penal Reform is a national organisation concerned with the state of prisons in the UK. The UoN Howard league continues their national work on campus by organising talks from speakers.

Amicus: Amicus is an organisation based in the USA which campaigns for the abolition of the death penalty and handles cases, pro bono, for individuals on death row. The organisation also provides real legal experience to volunteers by handling casework relating to death penalty cases

Community:

Access 2 Justice: A2J aim to use technology and communication platforms to enable members of the community to know about their rights. A2J are currently developing an app to help students with housing issues.

Junior Lawyers Against Poverty: JLAP works with Oxfam to raise awareness of the standard of justice in other countries and how we can improve standards.

StreetLAW: StreetLAW is a multi-faceted project.

- APPEAL: APPEAL students have the opportunity to be work on miscarriage of justice cases under the supervision of the legal team at APPEAL.
- Citizens Advice Bureau: Citizens Advice service's work involves providing advice on issues such as debt management and welfare benefits, housing, immigration and asylum, employment, consumer complaints and landlord-tenant disputes.
- inFrinGeMent: inFrinGeMent is a charity organisation that aims to raise awareness of female genital mutilation. Volunteers will create age-appropriate and sensitive presentations to deliver at schools.
- Support Through Court: STC offers students the opportunity to provide practical and emotional support to litigants in person in major civil and family court centres in England and Wales.

Legal Advice Clinic: A new project, the Clinic is a work in progress and are looking into providing advice on topics such as housing.

(TLEF) Justice First Fellowship: Justice First



What is the TLEF Justice First Fellowship?

'TLEF focuses on the essential role of legal education in helping people and organisations to understand and use the law as a tool for change. Too often people across the UK are unable to get support and expertise that may be needed for them to access justice. The Foundation recognised that in order to ensure the law is there for everyone who needs it, communities must have talented and committed social welfare lawyers'

The TLEF Justice First Fellowship aims to support this next generation of social welfare lawyers by sponsoring them through their training contracts.

To July 2021, the fellowship has supported 7 cohorts, 7 barristers and 103 new social justice solicitors to qualify. As a testament to the quality of Fellows and host organisations, 98% of graduated fellows are currently in paid employment with 91% working as lawyers using law for the public benefit to achieve a social good.

What does the TLEF Justice First Fellowship offer?

The fellowship provides a two-year fully funded training contract, and a free place on the Professional Skills Course at BPP campuses. During this period, Fellows spend two years working in leading UK organisations, which act as hosts and enable them to learn alongside the best in the profession.

While completing the Fellowship, Fellows also work with their host organisation to develop a project that will help advance access to justice. This is a crucial part of the scheme, helping Fellows to gain programme development experience and offering the hosts additional capacity to open up new areas of work and further meet legal needs.

2021 Hosts:


Anti Trafficking and Labour Exploitation Unit (ATLEU): a young charity providing legal representation to victims of trafficking and labour exploitation.

APPEAL: a charity and law practice that fights miscarriages of justice and demands reform.

Bhatt Murphy (with Article 39): Bhatt Murphy is a team of lawyers working together to make a contribution to the protection of civil liberties. Article 19 is a small, independent charity which fights for the rights of children living in state and privately-run institutions in England.

Bristol Law Centre: a charity providing free legal advice in specialist areas of social welfare law, and also represents clients in court.

Centre for Women's Justice: aims to bring together specialist lawyers, academics and other experts in the field of violence against women, with those working on the frontline as activists, survivors and service providers to bring strategic law challenges and ensure access to justice for victims of male violence.



The Legal Education Foundation's (TLEF) Justice First Fellowship Continued...

2021 Hosts continued:

Hopkin Murray Beskine: an established solicitors' firm with a focus on social welfare issues.

Housing Rights: works to help people in Northern Ireland deal with housing problems.

Howard League for Penal Reform: a charity whose work is aimed at reducing crime and making communities safer, with fewer people in prison.

Just For Kids Law: work with and for young people to ensure their legal rights are respected and promoted, and their voices heard and valued.

JustRight Scotland: expert lawyers who work with organisations who share their vision of a fairer and more equal Scotland – focuses on women's rights; migrant and refugee rights; anti-trafficking and exploitation; and equality and disability.

Law Centre NI: providing free independent legal advice and assistance to the public and to advisers.

Luton Law Centre: a not-for profit legal practice which gives professional, confidential legal advice and assistance.

North East Law Centre: an independent, not for profit, specialist legal practice based in the centre of Newcastle upon Tyne.

Shelter Scotland: strive to give people struggling with bad housing or homelessness the help they need, through our advice, support and legal services.

Speakeasy Law Centre: free legal advice across Cardiff and the Vale of Glamorgan, tackling social welfare issues including welfare benefits, debt, housing and employment law.

Suffolk Law Centre: aims to encourage them to implement policies and practices which will eliminate discrimination and promote equality of opportunity, and good relations, between all persons.

The Community Law Partnership (with Friends, Families & Travellers): an award winning, progressive firm of solicitors specialising in the law relating to

Housing and Public Law.

Tower Hamlets Law Centre: delivers specialist advice services to residents in the London Borough of Tower Hamlets in the areas of welfare benefits, immigration, housing and homelessness.

Vauxhall Community Law & Information Centre: aims to provide access to justice to our community on a range of social welfare issues.

Application Details:

Applications for each host are processed via the Justice First Fellowship scheme.

Application Timeline:

- June: opportunities posted.
- August: applications open.
- September: applications close and applicants notified of initial selection.
- October/November: interview period.
- January: training placements commence.

Requirements: -

- 1: must have passed the Legal Practice Course (or Bar Professional Training Course for Pupillage) in England and Wales.
- 2: must demonstrate a passion for access to justice, along with the highest level of skills and aptitude and the potential to drive innovation in future legal practice.
- 3: be willing and able to commit to serving a twoyear term as a Fellow.

Delving into Bhatt Murphy...

What is Bhatt Murphy?

Bhatt Murphy was established in 1998 by a group of lawyers who share a commitment to the protection of civil liberties. We offer specialist help to members of the public.

Their expertise includes:

- Public Law: purse public law challenges in all areas ranging through inquests, police complaints, data retention and criminal appeals.
- Police Misconduct: cases address all aspects of mistreatment and unlawful acts against those in custody and encompass false imprisonment and arrest cases, representing victims of unlawful police stop and search, failures to investigate hate crimes and crimes of sexual violence, the policing of protests and demonstrations, inquests and inquiries into custodial deaths, the illegal use and retention of data and the inappropriate use of reprimands and warnings.
- Prisoners' Rights: mainly act for prisoners needing advice or representation on parole and recall issues, reviews of tariffs for life sentenced prisoners, category A reviews and judicial review.
- Immigration Detention and Migrant Rights: act for individuals in civil claims for compensation, judicial reviews and inquests / inquiries; and NGOs as claimant or intervenors in judicial
- Detention Related Deaths: have particular experience working on deaths in custody by reason of restraint, police shootings and those which occur through self-harm.
- European Court of Human Rights: have extensive experience of pursuing European Court of Human Rights challenges which tend to arise from core areas of work.
- Women's Rights: act for individuals in civil claims for compensation, judicial reviews, inquests/ inquiries and domestic homicide reviews; and NGOs as claimant or intervenors in strategic judicial reviews - work includes: inquests

representing the families of women who were murdered by their partners where the police failed to protect them and judicial reviews about the restrictive abortion regime in Northern Ireland.

• **Public Inquiries**: examples include: The Hillsborough Independent Panel, The Leveson Inquiry and The Grenfell Tower Inquiry.

Summer Vacation Scheme:

- Every year, Bhatt Murphy offers four undergraduate students (of any academic discipline), their Summer Placement Scheme. Placements are paid at London Living Wage rates and we help with accomodation and travel costs for students living outside of central London.

Legal Path: Advising the Not-For Profit and Social Enterprise Sector:

Charities lawyers advising the not-for-profit and social enterprise sector cover a vast area of legal ground from wills and trusts to commercial and real estate law.

They can either work for a firm specialising in this area or in-house at larger charities.

Some lawyers specialise in litigation over disputed legacies; others focus on the creation and governance of registered charities and industrial and provident societies.

This type of work includes working on wills and trusts, advising on governance and managing charitable statuses and relationships with the Charity Commission. Charity lawyers often deal with enquiries regarding tax and VAT, inheritance law, data protection, contracts, mergers and takeovers, partnerships, fundraising, political activities and campaigning, trading, gaming and lotteries.

These lawyers may also deal with other areas that affect not-for-profit organisations such as employment law, dealing with land, intellectual property, financial services and media enquiries.



What Skills Do Charity Employers Want?

- Adaptability and Flexibility: You will need to be able to perform in multiple functions and work with a variety of people. You will also need to be able to adapt to fluctuating funding and resources.
- Commercial Awareness: You need to have a strong understanding of the charity sector and issues that may hinder an organisation from operating successfully.
- Commitment and Motivation: You need to be passionate about the cause that you're championing.
- Communication Skills: You need able to communicate effectively with a range of people including colleagues, service users, the public and the media.
- Creativity and Innovation: You need to be able to come up with new ideas.
- Negotiation and Persuasion: You need to be able to bid for funding, raise money and awareness for your cause, and get people to be as motivated as you.
- Organisational Skills: You need to be organised, especially with smaller charities where it is likely you will fulfil a

- variety of roles.
- Language Skills: This is not essential but speaking a second language would be helpful when working for an international charity.
- **Self-Awareness:** You need a willingness to grow and learn, to recognise your strengths and weaknesses and to admit when you've made mistakes.

What is CRCC Asia?

- Worthwhile is a graduate scheme for entry level jobs in charity, social enterprise and social impact.
- Worthwhile trains career starter from brilliant charities and social enterprises.
- Worthwhile offer a graduate scheme, training programme and recruitment only roles for young professionals taking their first steps in social impact.
- Worthwhile offer two routes into a social impact role: recruitment only and graduate scheme.
- They recruit candidates into roles based on the needs of their charity and social enterprise partner organisations.
- Worthwhile works with small, socially impactful organisations. These organisations are not big names but are small, ambitious organisations meaning you'll be offered responsibility and have lots of contact with senior staff members. Also, you'll often get insight across the breadth of an organisation and may work across multiple teams and functions.
- Organisations include: Generation Change, Student Minds and SocialSpider.
- For young professionals on the graduate scheme, Worthwhile provides 17 days of workshop-style training over the course of 12 months.
