



Commercial Awareness Updates

(i) Lidl or Aldi??? Consumers Must Get Used to Higher Food Prices

The UN Food and Agriculture Organisation has stated that the cost of ingredients like cereals and oils has caused global food prices to a 10 year high. Off the back of the COVID-19 pandemic, raw material production fell due to measures to control the virus — now, supplies haven't been able to keep up with returning demand. Kona Haque, Head of Research at the agricultural commodity firm, ED&F Man said "poor harvests in Brazil, one of the world's biggest agricultural exporters, droughts in Russia, reducing planting in the US and stockpiling in China have combined to push energy and shipping costs up".

Food for Thought: Kona Haque is also quoted saying that big food producers such as Kraft Heinz and Nestle will HAVE to pass these costs on to consumers. Will we see an effect on these companies' profits or will the full cost be passed on? What ways can companies combat this?

(ii) Split the Bills: Why So Expensive?

Energy regulator, Ofgem, says there will be further "significant rises" in fuel bills, despite millions of households already seeing an increase. This has been caused by the Government's decision to increase the energy price cap by 12%. Whilst this cap is usually to limit firms making unfair profits 'legitimate costs' have to be passed through. Why is this cost legitimate? Because worldwide there is a squeeze on gas and energy supplies. For instance, demand has increased by 250% since January and 70% from August 2021 alone. The UK has been hit badly since nearly 9 in 10 homes use central gas heating.

Food for Thought: As the price of energy increases, the number of energy companies is decreasing. Some industry experts are expecting that there could be a reduction from around 70 energy providers at the start of 2021 to 10 due to increased costs. This is an interesting one to follow as it provokes many environmental queries, rather than simply commercial ones.

(iii) Uh Oh... A Minimum Corporate Tax Rate?

US Treasury Secretary, Janet Yellen, has said that "virtually the entire global economy has decided to end the race to the bottom on corporate taxation" as 136 countries agree to a 15% minimum corporate tax rate. This follows concern that multinational companies are rerouting their profits through low tax jurisdictions; it is predicted that the deal could bring in an extra £108b of tax a year, bolstering the global economy as they all recover from COVID-19. The move – which is expected to hit digital giants like Amazon and Facebook – will affect firms with global sales above £17b and profit margins above 10%. A quarter of any profits they make above the 10% threshold will be reallocated to the countries where they were earned and taxed there.

Food for Thought: This deal marks a sweeping change when it comes to taxing large corporates. In the past, countries competed with each other to offer attractive deals to multinationals. As we enter a new digital era, giants have become adept at simply moving profits around to pay the least tax. Ponder upon whether this move is good... whilst it of course is great for geopolitics as countries reach a unified agreement, it could impact those lower down the corporate chain, for instance, factories and job-seekers as large corporates relocate less and create fewer opportunities for work.
